Seller is not responsible for any sickness/disease etc. due to a non-vaccinated puppy. Seller is not responsible for any reactions caused by vaccinations.
2. Your puppy is Guaranteed for 1 (one) year from the date of whelp against hereditary and congenital defects that are life threatening. This guarantee does not include any health issues caused by neglect or injury. There are certain disorders that may be caused by environmental factors, for example: allergies, thyroid dysfunction, demodectic mange, and other autoimmune disorders that ***are not covered*** by this guarantee.

3. ****This guarantee does not warrant that a veterinarian has examined this puppy. The buyer, at their own expense, should have the puppy examined by a licensed veterinarian within 3 days of receiving the puppy (within 5 days if puppy has been shipped via airlines). If within 3 (or 5) days, a licensed vet finds the puppy to be unhealthy or unfit for sale, the puppy may be returned for a full refund provided the puppy has not been injured or neglected. The veterinarian must provide a written statement deeming the puppy "unhealthy for purchase" along with the health issues.
